As an eligible Active Participant, you have an extensive package of benefits that includes comprehensive medical, hospital, prescription drug, behavioral health and substance abuse, vision, dental, and life insurance coverage. In addition, our contracted wellness program offers you preventive screenings and educational programs. Participants who are in the Los Angeles area and who are enrolled in the Motion Picture Industry Health Plan/Anthem Blue Cross PPO plan have the option to see a primary care physician and specialists participating in The Industry Health Network (TIHN). TIHN is a network of physicians put together for people who work in the entertainment industry. These participants will only be required to pay a \$5 co-payment for office visits and will have covered services paid at 100% of the allowable amount. To have access to a TIHN primary care physician and specialists, please contact the UCLA-Motion Picture & Television Fund (MPTF) Health Centers. A referral from UCLA-MPTF Health Centers is required to see a specialist.

On and after October 28, 1990, all contributions received by the Pension Plan (other than Unclaimed Vacation & Holiday Pay) are Employer contributions. Prior to October 28, 1990, \$0.164/hour was deducted from a Participant's paychecks each pay period and remitted to the Motion Picture Industry Pension Plan ("MPIPP") toward individual pensions. The Individual Account Plan ("IAP") is also 100% Employer-funded.
